

## Friends of Victoria Park, Glasgow

Minutes of our Committee Meeting at 7.30pm on Wednesday 29th June 2022

## Matters arising will be dealt with under the appropriate agenda item.

- 1. Apologies: Maggie McTernan.

- 2. Approval of minutes of last meeting: proposed by GH and seconded by JC.
- 3. Victoria Park Community Trust update (including People make Glasgow Communities update, Vision/Park plan: Participation Interest, Mountain Bike Track, Outdoor Gym, FG lease issues, Grant applications, JCC reapplication, Parkrun, and other relevant VPCT info.)

There have been no further updates with regard to PMGC.

We have not yet had another meeting with GCC to formalise our relationship regarding the Participation Request. We may have to re-think our approach to the process, if GCC continue to stall.

Thornhill Community Council may be re-joining. We anticipate that JCC will re-start at some future point and perhaps resume engagement with VPCT.

Kevin McCormack is said to be taking the lead regarding the dirt track. There is to be a meeting with John Fern, which he facilitated. The anticipated time scale is one month for design and two for procurement. It will be October before finalisation of these phases, after which works may commence.

Ground works for the Outdoor Gym may form part of the same works.

The Fossil Grove Trust is forming a one tier SCIO. It has been proposed that VPCT will nominate two Trustees.

With regard to PMGC and works to the Fossil House, Stephen Blanchflower is our main point of engagement at present.

RM advised that RMK and he were Administrators and that Ada Scarott (AS) was a moderator. The committee was happy for this arrangement but with the addition of Joyce as a moderator.

RMK advised of his desire for greater Committee involvement in decision making and policy regarding FB.

EB advised that difficulties in organising the work of NRS teams was a cause of problems controlling glysophate use.
